The Clovis Community College Board of Trustees held its regular meeting on Wednesday, May 1, 2024, at 8:00 a.m. in room 512.

Faculty NISOD Awards:

TRIO Student Support Services Program Review: TRIO Student Support Services (SSS) is a federally funded educational opportunity outreach program designed to retain, graduate, and transfer eligible students. The program provides academic support, aid in postsecondary course selection, information concerning financial aid programs and benefits, informational resources for locating both public and private scholarships, and assistance in completing financial aid applications. Education and counseling services are offered to improve the financial and economic literacy of students. Through transfer advising, participants are prepared for admission to four-year and professional programs. This year marks TRIO's 23rd year on campus. CCC is submitting for another five-year grant that will run through 2029. Ms. Joleen Borja, Director of TRIO SSS, and her staff are currently serving 175 active participants. She provided the Board with an overview of the program.

Clovis Community College students and participants of TRIO SSS, Ms. Catherine Anaya and Ms. Eisa Lopez shared their testimonies and spoke about the vast support they received from the TRIO SSS team.

Spring 2024 Graduation List:

The Spring 2024 graduation list includes 221 associate degree earners, 103 certificates of completion, and 155 certificates of achievement, for a total of 479 graduates. This is an increase of more than 100 compared to the Spring 2023 graduation list. A commencement ceremony recognizing graduates from the 2023-2024 academic years will be held at 6:00 p.m. on Friday, May 10, 2024, at the Curry County Events Center. There will be 160 students participating. It was requested that the Board of Trustees approve the Spring 2024 graduation list as submitted.
